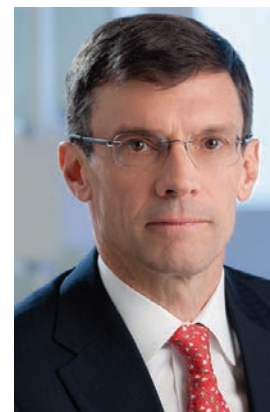

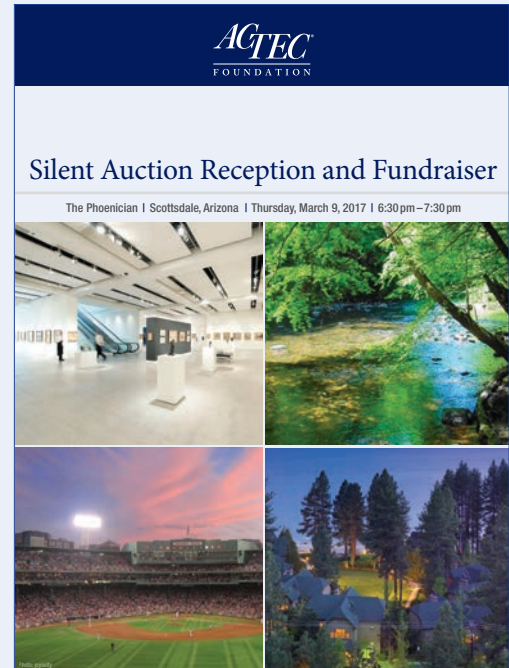
2017 Annual Meeting Silent Auction Reception and Fundraiser

Fall 2017 Bike Ride Fundraiser - Bike the Natchez Trace Parkway



Join our ACTEC Foundation fall 2017 cycling fundraiser for an exciting ride along the nation's longest dedicated bike path.

The Natchez Trace Parkway is a two-lane, 444-mile paved roadway that crosses Mississippi, Alabama and Tennessee. There are no stop-signs or traffic lights; there is a wide shoulder to ride on; no commercial traffic is allowed; and

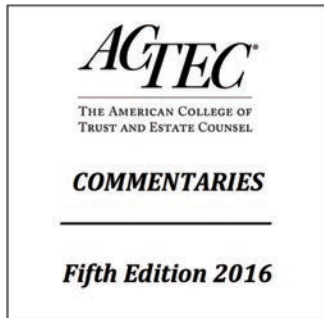
the vehicle speed limit is 50 mph or lower. In sum, the route is as safe as a bike route can be. It is also reasonably flat and renowned for its beautiful and varied scenery and 95 historical and natural "sights to see".

This tour was designed so that participants can choose to ride at their own pace. Each day will have a choice of segments at varying lengths: 20-30 miles; 40-50 miles; and 60-75 miles. The ride will be supported by a professional tour operator who will coordinate logistics, make all lodging arrangements, and provide all meals, including picnic lunches along the route. Two companion vans will also provide on-road support, to ensure that each cyclist has sufficient water, snacks, and mechanical support, as well as a place to rest or stop riding before the end of the day's route.

Cyclists will arrive in Natchez on October 12, 2017, start riding on October 13, and arrive at the Omni Hotel in Nashville on October 19, 2017, in time for the beginning of the Fall Meeting.

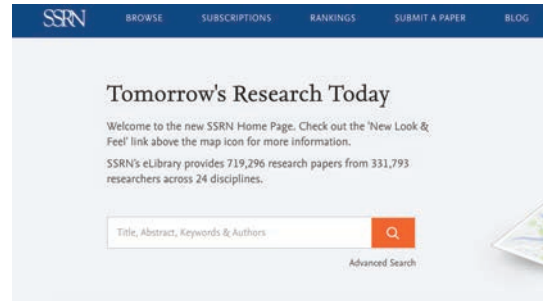
