The Foundation Approved Three Grants

At its July 8, 2025, Business Meeting, the ACTEC Foundation Board approved three new grants supporting education, outreach, and equity in trust and estate law:

- 1. Funding was awarded for the Dennis I. Belcher Young Leaders Program which provides successful graduates of the two-year ABA RPTE Fellows Program with financial support to attend RPTE Section meetings, invitations and financial support to attend ACTEC Regional and State Meetings, as well as Stand-Alone sessions at the ACTEC Summer Meeting, and ACTEC/ALI CLE webinars at no cost. This grant will support the Eleventh Class of Young Leaders, building on a legacy that has already seen sixteen program alumni elected as ACTEC Fellows.
- 2. **Bet Tzedek Legal Services** received a Foundation grant to support the second year of its Postgraduate Fellow for Equity in Trust and Estate Law. In partnership with UCLA Law, this fellowship provides free, high-quality estate planning services to low-income and vulnerable individuals across Los Angeles County.
- 3. ACTEC's Communications Committee was awarded funding to continue the production of the ACTEC Trust and Estate Talk podcasts and the ACTEC Estate Planning Essentials videos. These resources serve as valuable tools for informing both professionals and the public about key topics in estate planning, fiduciary responsibility, and wealth transfer.

The Foundation Supports the Antonin Scalia Law School Symposium at George Mason University



On September 26, 2025, the

Symposium on the Law and Economics of Wealth Management and Transmission was held at Antonin Scalia Law School at

George Mason University, in Arlington, VA. This is the second Foundation grant awarded to George Mason University to support the Symposium of the *George Mason*

Law Review. Organized by Academic Fellow Thomas P. Gallanis, the event convened leading scholars to present papers exploring key legal issues in wealth management and transmission. The papers will be published in Volume 33, Issue 2 of the George Mason Law Review.



On July 22, 2025, Foundation President John T. Rogers, Jr., and Co-Chairs of ACTEC's Legal Education Committee, Elizabeth A. Bawden and Gerry W. Beyer announced the winners of the 2025 Mary Moers Wenig Student Writing Competition. Three submissions from law students across the country stood out among the 32 entries evaluated by a panel of judges appointed by the Legal Education Committee, with four additional submissions receiving Honorable

Mention. T. Randolph (Randy) Harris, who chaired the judging process on behalf of the Committee, shares: "This year's competition saw an impressive number of submissions from law students across the country, and the overall quality of writing and analysis was exceptional, making the judging process quite challenging. The prize-winning entries stood out for their originality, clarity, and thoughtful engagement with both emerging and traditional trust and estate issues."


